2. Structure, Governance and Management

2.1 Governing Document

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the By-Laws of the Association and the Policy, Organisation and Rules (POR) of the Scout Association.

2.2 Group Scout Council

The Group Scout Council is the electoral body to which the Group Trustee Board is accountable. Membership of the Group Scout Council is open to:

- Scouters
- Colony, Pack and Troop Assistants
- Administrators
- Advisers
- Patrol Leaders
- All parents of Beavers Scouts, Cubs Scouts and Scouts

• any other supporters including former Scouts and their parents who may be admitted by the Group Scout Leader, the Group Trustee Board, or the Group Scout Council

2.3 Constitution

The Group is operated as an educational charity under the Policy, Organisation and Rules of the Scout Association. It has a constitution agreed by the Group Scout Council, but which is subservient to its governing documents.

2.4 Trustee Selection

The trustees are appointed in accordance with the Group's constitution and the Policy, Organisation and Rules of the Scout Association.

2.5 Group Trustee Board

The Group is led by a Group Scout Leader and managed by a Group Trustee Board. They are accountable to the Group Scout Council for the satisfactory running of the Group.

The Trustee Board exists to support the Group Scout Leader in meeting the responsibilities of their appointment.

Members of the Trustee Board must act collectively as charity Trustees of the Scout Group, and in the best interests of its members to:

- Comply with the Policy, Organisation and Rules of The Scout Association
- Protect and maintain any property and equipment owned by and/or used by the Group.
- Manage the Group finances.
- Provide insurance for people, property and equipment.
- Provide sufficient resources for Scouting to operate. This includes, but is not limited to, supporting recruitment, other adult support, and fundraising activities.
- Promote and support the development of Scouting in the local area.
- Manage and implement the Safety Policy locally.
- Ensure that a positive image of Scouting exists in the local community.
- Appoint and manage the operation of any sub-Committees, including appointing a Chair to lead the sub-Committees.
- Ensure that Young People are meaningfully involved in decision making at all levels within the Group.

- The opening, closure, and amalgamation of Sections in the Group as necessary.
- Appoint Administrators, Advisers, and Co-opted members of the Trustee Board.
- Approve the Annual Report and Annual Accounts after their examination by an appropriate auditor, independent examiner, or scrutineer.

2.6 Risk and Internal Control

The Group Trustee Board has identified the major risks to which they believe the Group is exposed which are:

2.6.1 Injury to Leaders, Helpers, Supporters or Members

The Group supports compliance with the Safety Policy and ensures appropriate risk assessment; elimination, reduction and control measures are taken to reduce the likelihood of any injuries.

In addition, through membership fees, the Group contributes to the Scout Association's national accident insurance policy.

2.6.2 Damage to Buildings, Property or Equipment

The Group would request the use of buildings, property and equipment from neighbouring organisations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.

2.6.3 Reduced Income from Subscriptions and Fund Raising

The Group is primarily reliant upon income from subscriptions and fund-raising. The Group holds adequate reserves to ensure the continuity of activities should there be a major reduction in income. The board could also raise the value of subscriptions to increase the Group income either temporarily or permanently.

2.6.4 Reduction or Loss of Leaders

The Group is totally reliant upon volunteers to run and administer the activities of the Group. If there were a reduction in the number of volunteers to an unacceptable level, then there would have to be a contraction, consolidation or closure of activities or sections.

2.6.5 Reduction or Loss of Members

If there were a reduction in membership of a particular section or the Group as a whole then there would have to be a contraction, consolidation or closure of a section.

3. Objectives and Activities

The primary objective of the Group is that of the Scout Association generally, namely:

"to actively engage and support young people in their personal development, empowering them to make a positive contribution to society."

The Values of Scouting

As Scouts we are guided by these values:

- **Integrity** We act with integrity; we are honest, trustworthy, and loyal.
- **Respect** We have self-respect and respect for others.
- Care We support others and take care of the world in which we live.

The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

The activities of the Group are:

• The provision of the Scouting programme for 6–14 year old members

4.4 Beavers Section Report

We have had an amazing year at Beavers. At the time the report was written we have 26 active Beavers.

We have had a great year and had lots of fun. We have covered many badges including builder, craft and adventure. We have awarded 137 badges and 7 Beavers achieved the highest accolade, the Chief Scout Bronze Award before leaving us to move up to Cubs.

The Beavers have taken part in various activities throughout the year. In the Autumn Term we attended the District "35 years of Beaver Scouts Birthday Bash", we went to QCW to play night games, we made cakes for McMillan, we attended a joint messy church with the rest of the group and made Harvest craft, we attended the Harvest festival.

We went to QCW and took part in a spooky walk, hosted by other scouts – it was ace. We joined together with the other sections and made Remembrance Day crafts and left them at church when we paid our respects. We attended the Christmas Light switch on in the village. We made Christmas gifts for our families and went to see Santa at the hayrack.

In the Spring Term, we went to the Chester Gang Show, which resulted in some of our Beavers wanting to take part in one next year. Our theme for this term was joining in. 4.5 Cubs Section Report

Building on our successes of 2021, it's been another exciting and busy year for the Cubs section! Our numbers have grown to 20 young people, with most attending each week – although we will shortly be losing some of our Cubs as they continue their Scouting journey into Scouts.

Following the Summer Break of 2022 and up to Christmas, the Cubs were busy establishing their mapping skills, joined the Beavers and Scouts at the Harvest Service (with a difference), made Bug Hotels out of hanging baskets as well as getting out and about around Ince and Elton across several evenings.

The Cubs also visited the Fire Station, worked on Home Help and Safety, had a visit from Cheshire Police before finishing off with a Christmas Treat with Ten Pin Bowling.

Moving into 2023, the Cubs have continued to work on their badges, with highlights being the GIAI Sleepover at Chester Cathedral, the Mother's Day Pamper Night in March, Animal Care and the Group Camp at Tatton Park – where a number of our Cubs got the chance to try Kayaking and Raft Building.

On behalf of the leadership team, I would like to thank all the young people for showing up every week and taking part in all the activities and showing great enthusiasm.

I would also like to take the opportunity to thank all the leaders and helpers (Christie, Kim, and Tina) for their continued support and dedication to providing great activities for the Cubs.

4.6 Scouts Section Report

2022 was a very enjoyable year with the following activities that were well attended:

- A trip to Games Workshop in Chester to make Warhammer models Ticking off elements of the Creative Challenge badge.
- Kayaking on the River Dee (Water activities).
- Orienteering at Delamere Forest Orienteering activity badge.
- Ice skating Christmas trip Teamwork Challenge badge.
- Visit Chester Gangshow
- Crossbow Shooting at QCW Master at Arms activity badge.
- Aqua Chimp at Wildshore Delamere.

We also took part in a "Wellbeing Weekend" at QCW with the district YouShape team.

A group camp at Tatton Park was a great time with the Scouts taking part in Kayaking and Raft-Building with thanks to permit holders from other groups in the district.

4 of the Scouts took part in a District Challenge Day at QCW with our group taking 4th place behind some very strong teams, one of which is now going on to represent Cheshire after taking the Mersey Weaver title.

We had 2 teams competing in the Cheshire Hike – Chloe and Harry doing a great job completing the Pathfinder route, and Tillie joining 2 other Scouts from Widnes and Moore completing the Pathfinder+ route.

Finally, but certainly not least we have 1 Scout who has done an amazing job achieving her Gold award.

We have got lots planned for the next year including a mini expedition (run similarly to the Cheshire Hike, albeit shorter distance) which will encourage the older Cubs to take part in a hike and camp-over.

5. Financial Review

5.1 Treasurer's Report

Nicole McNally – Treasurer

The beginning of 2022, saw the completion of the renovations to the external area of HQ were completed with the cladding being installed. We also changed the internal doors to fire doors to adhere to regulations with the intention of having sleepovers in the Hut for some of our younger members.

We continued our fundraising events, with the Fireworks display being as popular as ever, despite no bonfire and now referred to as our Firework Spectacular.

We are now using a new accountancy tool which links to OSM to keep our financial records, so this year's data is presented slightly differently to previous years.

Donations and Grants

We were fortunate to receive donations from The Charities Trust, Elton Parish Council and fund matching through people working in the finance sector. The Firework Spectacular continues as our most successful fundraising event.

Fundraising

The Firework Spectacular continues as our most successful fundraising event, which raised over £2,700 after expenses including donations.

Outings and Activities

The children have taken part in lots of activities and several outings further outlined in the section reports. The $\pm 1,599.75$ figure is the amount we have collected from parents/carers for outings and activities.

The total expenditure for 2022 was **£22,562.47**.

Renovations for the hut were completed in this year, including the external cladding and internal fire doors to permit us to have sleepovers for the children at HQ. The events and activities were subsidised more this year as shown when comparing the expense with the income for activities/events.

Subscriptions

Membership fees cover the costs of the group, including the Census, hut maintenance, weekly activity costs, etc. We calculate a yearly cost and then divide by 12 for lower monthly payments, so please all be aware that the subs don't stop during the holidays. We are trying to continue with the ± 12 per month sub fee for as long as feasibly possible.

Bank Accounts

Amounts held in Bank Accounts or cash as at 31/12/2022 were £34,735.77. A full set of the Annual Accounts for 2022 are included in the appendix below.

5.2 Reserves Policy

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short.

The appropriate level of reserves for operating the group for 6 months is judged to be circa $\pm 6,000$.

As reported earlier in this report, the group ended 2022 with total funds, including reserves and grant monies of £34,735.77, which is above the level required for operating expenses. However, this can be explained by:

- Not being able to spend the surplus from last year with the receipt of COVID-19 grants from the local authority accruing in 2020 and 2021.
- continuing to hold a contingency for the final phase of the HQ External Works Project in case any unforeseen issues arise.
- the Group Trustee Board was also mindful of the ongoing situation with rising energy prices and wished to hold extra reserves for this purpose until the next review of our reserves policy.

5.3 Investment Policy

The Group's Income and Expenditure is very small and consequently, does not have sufficient funds to invest in longer-term investments such as stocks and shares. The Group has therefore adopted a low-risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies or The Scout Association's Short Term Investment Service.
